## Looking Ahead to 2021-2022 School Year

- Given the impact of COVID-19, RB Sports Boosters has been unable to open for a single concession event since Spring of 2020. After a long break from any kind of concession stand fundraising, RB Boosters is excited to be able to support concession stand sales during live athletic events in this upcoming 2021-2022 school year.

## Key Accomplishments in 2020-2021

- Booster Senior Scholarship**
  - RB Boosters presented our second annual slate of RB Sports Boosters Senior Bulldog Scholarships in Spring of 2021. Main criteria are summarized below.

### Criteria

- There were 10 applicants – 3 males and 7 females.
  - Per process, Boosters awarded scholarships to 4 Bulldog student athletes (2 male, 2 female for a total of 4 Bulldogs each receiving \$500).
  - The Booster Executive Board is committed to seeing that this scholarship offering is available year over year and updated the bylaws last year to ensure continued funding.
- Bulldog Bonanza**
  - The Booster Executive Board, in an effort to implement creative and alternative ways to support fundraising in the 2020-2021 school year during a pandemic, launched a pilot Facebook-based online auction event.
  - The event, coined “Bulldog Bonanza” ran for about 6 weeks and involved online bids for items such as services or goods from local businesses.

- Nearly 960 members joined the Bulldog Bonanza group—and we were able to partner with dozens of local businesses to make auction offerings.
- It resulted in a fundraising PROFIT of more than \$36,000.
- It was a rousing success—and we hope to implement it again later this school year.

## Pandemic Adjustments

- **Team Metrics**

- In year’s past, RB Sports Boosters have measured parent involvement via tracking membership rate and volunteerism per sport. In the 2020-2021 school year, where little activities could be held, we made the decision to allow all parents to be Booster members—without a membership fee or registration process. We encouraged feedback from the parent community with the hope of keeping parents engaged until the following school year.
  - Because there was no formal membership registration, it is not possible to do metrics nor can we summarize what may have been membership growth for a 6<sup>th</sup> year.
  - Membership registration is back on for the 2021-2022 school year, and we have high hopes for impressive numbers in the coming school year.
